Swiss Pensions Conference Zurich - Investing in a Polarised World

On 19 June, Swiss pension professionals joined us at the Dolder Grand for the annual Swiss Pensions Conference Zurich.

At this year's Swiss Pensions Conference, Howard Marks, Co-Chairman, Oaktree Capital Management, opened with insights on market cycles, risk, and investing in a polarized environment. A CIO panel from Swiss and Dutch pension funds examined infrastructure's role in delivering long-term, stable returns. Eveline Takken-Somers, Deputy Head in the CILI team and the Lead Portfolio Manager of the Insurance portfolio, reviewed insurance-linked investments as a diversification and volatility hedge. In a "Joker Session," Dr. Thomas Zurbuchen, Head of ETH Zürich | Space, shared lessons on resilience and decision-making under uncertainty. Christoph Heusgen, Chairman of the Munich Security Conference from 2022 to 2025, closed with a geopolitical outlook. Across the day, discussions addressed inflation, regional dynamics, and advances in technology and sustainability.

It was an energising, well-attended day that left participants inspired and better equipped for the road ahead.





Generations Conference - Strong Roots, Bold Moves: Bridging Legacy and Innovation

On 22 September, we hosted our flagship Generations Conference 2025 at the Dolder Grand. Carl Elsener, CEO & Chairman, Victorinox, delivered a brilliant opening keynote on building a global brand from heritage and innovation, followed by Prof. Dr. Thomas Zellweger, Professor, HSG, on Transgenerational Entrepreneurship: The Science of Family Success. A Single Family Office Investment Panel tackled Navigating Uncertainty, while other sessions explored how AI is reshaping drug development and spotlighted forwardlooking opportunities from convertible bonds to EM small-cap equities. The Future-Fit Private Wealth panel-Frédéric Hoffmann, President, Unearthodox, and Andrea La Mesa, Co-CEO, The Life You Can Save, ex Airbnb, Entrepreneur, Investor moderated by Dr. Falko Paetzold, Founder, Center for Sustainable Finance and Private Wealth (CSP) and CCSP at University of St.Gallenchallenged us to rethink tradition, legacy, and purpose. We closed with Rudolf Hilti, Founding Chair of The System Change Foundation [THE HUS & World Systemic Forum], Founding Board of Re-State Foundation and Ecosystem Builder @RHEINEST Holding, on The Future of Wealth with Purpose, before networking breaks capped a high-energy day of peer exchange.
